- UNIVERSITY ACT 2019

- COPYRIGHT ACT 2014

OPHAVSRETSLOVEN (LBK NR. 1144 AF 23/10/2014 KULTURMINISTERIET)

NORDIC MODEL

ACADEMICS ALSO HAVE AUTHORS' RIGHTS AND ARE ENTITLED TO REMUNERATION.

- VOLUNTARY AND CREDIBLE AGREEMENTS – ALSO WHEN IT COMES TO AUTHORS' RIGHTS.
- LICENSING AGREEMENT
- ROLE OF COLLECTIVE MANAGEMENT ORGANIZATIONS
- REMUNERATION OF AUTHORS

NORDIC MODEL

- UBVA (THE COMMITTEE FOR THE PROTECTION OF SCIENTIFIC AND SCHOLARLY WORK)
- AKADEMIKERENE (THE DANISH CONFEDERATION OF PROFESSIONAL ASSOCIATIONS)

EXAMPLE: COPYDAN

UNIVERSITY GUIDELINES STATE.....

- THE COPYRIGHTS LIE WITH THE CREATOR (LECTURER).
- ALL TEACHING MATERIAL CREATED BY THE LECTURERS MUST HAVE THE NAME, TITLE AND PLACE OF WORK OF THE CREATOR AS WELL AS THE TIME OF CREATION. THIS INFORMATION MUST BE STATED ON ALL WORK THAT IS CREATED.
- THE UNIVERSITY IS ENTITLED TO USE THE TEACHING MATERIAL TO THE EXTENT NECESSARY FOR UNIVERSITY'S CORE ACTIVITIES.
- AFTER A SPAN OF 5 YEARS, THE LECTURER MAY REQUEST FOR DELETION OF THE RECORDINGS.
- THE UNIVERSITY MAY NOT ASSIGN THE RIGHTS TO A THIRD PARTY WITHOUT THE CONSENT OF THE LECTURER.
- THE GUIDELINES ARE ADJUSTED EVERY SECOND YEAR IN THE AUTUMN SEMESTER.
